The faculty members adopt approved teaching-learning methods and prepares lesson-plan including course outcomes, course objectives, content topics, reference books etc. The College encourages its faculty members to participate in Orientation, Refresher Courses, Workshops and Seminars organized by the University and AICTE approved Institutes to make aware of themselves with modern technologies. Re-assuring faculty members to evaluate their own teaching skills and teaching practices. Every Faculty member tries to achieve Course Objectives (CO), Program Objective (PO) and Program Specific Objective (PSO) of their branch of study is framed. The Students of that branch would have gained strong fundamental knowledge and acquired enough managerial skills for lifelong learning. The College provides ample books and other learning materials like journals, magazines, teaching models and software to enable its Faculties to ensure operative carriage of curriculum. Library committee conducts meeting and takes appropriate decision regarding prerequisite and procurement of books, periodicals, e-journals. The teaching and laboratory plans are approved by Head of the Departments undersigned by Principal before the starting of Semester and communicated to the students by respective course Faculty. The course files are evaluated by Internal Quality Assurance Committee (IQAC) with help of concerned senior subject Faculty and HoD. IQAC monitors the academic activities on regular basis to ensure the execution of time-table. It also monitors implementation of academic calendar and teaching learning process. These records are submitted to head of the institution every month for verification and necessary suggestions for quality addition.
